# **AEIOU Financial Comic Strip Challenge 6**

## **Faber-Castell Special Awards Category**

### **Terms & Conditions**

## 1. CHALLENGE PERIOD

1. The AEIOU Financial Comic Strip Challenge 6 (“Challenge”) is organised by Alliance Bank Malaysia Berhad (“ABMB”) in collaboration with A.W. Faber-Castell (M) Sdn. Bhd. (“FC”) and shall run from 1 June 2021 to 2 July 2021 (both dates inclusive) or such other time period as may be notified by ABMB from time to time (“Challenge Period”).
2. ABMB reserves the right at any time with prior notice to change the duration and/or the commencement and/or expiry dates of the Challenge Period.

## 2. ELIGIBILITY

- 2.1 This Challenge is open to following individuals:
  - a) Malaysian students from Primary 4, 5 & 6.
  - b) Children from ages 9 to 12.

## 3. CHALLENGE MECHANICS

- 3.1 All entries are required to be created on one A4-size drawing block paper (size 21cm x 29.7cm), excluding the cover. Each A4 size drawing block is to be folded into half with the measurement of 21cm x 14.8cm.
- 3.2 Comic must be drawn on at least 1 piece of folded A4 size drawing block (total 4 pages) using Faber-Castell stationeries only.
- 3.3 All entries are based on the following theme, “**Saving For A Rainy Day: Preparation During Crisis**”.
- 3.4 Captions or dialogues within the comic strip entries shall be in English or Bahasa Malaysia.
- 3.5 All entries are to attach a complete contest form which can be obtained from the AEIOU website (<http://www.alliancebank.com.my/aeiou>). The contest form is to be printed and pasted at the top right corner on the last page (behind the cover page).
- 3.6 Participant(s), parents/legal guardian of the participants are required to do **ALL** of the following:-
  - (a) post a picture featuring the participant with the cover of their comic booklet together with any Faber-Castell stationery product on Facebook or Instagram;
  - (b) The post caption must include the hashtags: #AEIOUChallenge2021 and #FaberCastellMY, and tag @alliancebankmy; and
  - (c) the post privacy must be set as public.

failing which the entries will be disqualified automatically without prior notification.

## 4. CHALLENGE TERMS AND CONDITIONS

- 4.1 Each participant may submit multiple entries. However, only one (1) entry shall be accepted to qualify as the winner.
- 4.2 The judging process of all entries will be conducted by FC and it will be based on picture’s creativity and attractiveness.
- 4.3 All winners for the Faber-Castell Special Awards Category will be notified through a post on Facebook and Instagram. The winners are required to respond via direct message to ABMB. If the winner cannot be contacted or does not claim the prize within 14 days from the date of notification, ABMB reserve the right to withdraw the prize from the winner and select another winner.

- 4.4 All entries must be posted on Facebook or Instagram in accordance with Clause 4.3 NOT LATER than 5pm on 2 July 2021 (Friday). Any entries received after the specified time will not be accepted.
- 4.5 Any entry which does not comply with any of the Terms and Conditions stated herein WILL BE DISQUALIFIED AUTOMATICALLY, without prior notification.
- 4.6 By participating in this Challenge, the participants and/or participant's parents/legal guardian shall be deemed to have granted ABMB and FC the exclusive permission to use their names, photographs, voices, and likeness in connection with this Challenge for marketing and advertising in any form or medium.
- 4.7 Prizes for the winners are as follows:
  - a) The First Place Winner will receive a Faber-Castell product hamper worth RM400 and a certificate.
  - b) The Second Place Winner will receive a Faber-Castell product hamper worth RM250 and a certificate.
  - c) Six (6) consolation prize winners will each receive a Faber-Castell product hamper worth RM100 and a certificate.
- 4.8 All winners will receive their prizes during the prize giving ceremony ("Awards Ceremony"). The exact date of the Awards Ceremony will be communicated to the shortlisted winners later.
- 4.9 This challenge is NOT sponsored, endorsed or administered by, or associated with, Facebook, Instagram or any other Social Network in any manner. All your information is deemed to be provided to ABMB and FC, not to any other party.

## **5. GENERAL**

- 5.1 By participating in this Challenge, participants are deemed to have read, understand and unequivocally accepted and agreed to be bound by the Terms and Conditions herein ("Challenge T&Cs") including any amendments or variations to it and unequivocally accept the same in its entirety. ABMB and FC's decision on all matters relating to this Challenge shall be final and binding on all the participants and no correspondences and/or appeals in respect thereof shall be entertained.
- 5.2 ABMB reserves the right to cancel, terminate, suspend or extend this Challenge and to add, delete, suspend or vary the Challenge T&Cs contained herein, wholly or in part at its absolute discretion with prior notice by way of posting on ABMB's website, display at branch premises or advertisements or by any other means of notification which ABMB may select and such shall be binding on the participants as from the date of the notification or from such other date as may be specified by ABMB in the notification. Participants and their guardians agree to access ABMB's website at regular intervals to view the Challenge T&Cs and deemed to have agreed with any addition, deletion, suspension or variation to the Challenge T&Cs.
- 5.3 The participants hereby give their unequivocal and irrevocable consent and authorise ABMB to disclose their particulars to any third party service provider engaged by ABMB for the purpose of this Challenge.
- 5.4 By participating in this Challenge, the participants agree that all entries shall belong to Alliance Bank. Alliance Bank can choose to use the entry in any manner it may deem fit at its absolute discretion in any of its promotional or educational activities..

- 5.5 ABMB shall not be responsible for any technical failures of any kind, whatsoever intervention, interruption, electronic error and/or any failure or delay in the transmission of evidence by postal or telecommunication authorities or any other party which may affect the participants entitlement during the Challenge Period.
- 5.6 The participants hereby give their unequivocal and irrevocable consent and authorise ABMB to use, publish and/or display the names, any photographs taken, any videos recorded and/or other information for current and future advertising and/or promotion purposes in any manner it deems appropriate without any compensation or need for their express consent.
- 5.7 ABMB reserves the right to disqualify the participation of any Participants or forfeit the Challenge Prizes in circumstances where there is a fraudulent, unauthorised or reversal of transactions or breach or potential breach of the Challenge T&Cs at its discretion. All records of ABMB on the transactions made shall be deemed conclusive and final.
- 5.8 For the avoidance of doubt, any cancellation, termination, suspension or extension of this Challenge or disqualification of participants or forfeiture of the Challenge Prizes “shall not entitle the participants to any claims or compensations against ABMB or for any and all losses or damages suffered or incurred by the Participants as a direct or indirect result of the act of cancellation, termination, suspension, extension, disqualification or forfeiture.
- 5.9 ABMB shall not be responsible nor shall accept any liabilities of whatsoever nature howsoever arising or suffered by participants resulting directly or indirectly from this Challenge. ABMB shall not be or held responsible to the participants in any manner whatsoever if ABMB is unable to perform any of its obligations under this Challenge directly or indirectly due to any force majeure event which include but not limited to any act of God, war, strike, riot, pandemic, industrial dispute, lockout, fire, drought, food, storm or any event beyond the reasonable control of ABMB.
- 5.10 Any matter with regards to the Challenge which is not covered in this Challenge T&Cs will be determined by ABMB at its sole discretion.
- 5.11 The eligible participant shall be personally responsible for all taxes, rates, government fees or any other charges that may be levied against them under applicable laws, if any, in relation to this Challenge.
- 5.12 The Challenge T&Cs shall be governed by and construed in accordance with the laws of Malaysia and the participants agree to submit to the exclusive jurisdiction of the Courts of Malaysia.
