# **MyDebit – Isetan Fabulous Living Contest**

# **Terms & Conditions**

- 1. The Isetan's "MyDebit Shop Cashless; Win Prizes" [referred as "Contest"] is jointly organized by Isetan and Payments Network Malaysia Sdn Bhd (PayNet)[referred as "Organiser"] is open to all Malaysian aged 18 and above, except for the employees of the Organiser, their affiliates and their related companies, members of their immediate families (parents, spouse, son /daughter). The Contest period starts from 1st September 2018 until 31st December 2018 ("Contest Period").
- 2. By participating in the Contest, the Participants are taken to have read, understood and agreed to abide by and be bound by these terms and conditions of the Contest, the Data Protection & Privacy Notice as detailed below, and all amendments, additions, replacements deletions and modifications hereto ("Terms and Conditions") as may be made from time to time by the Organiser and be bound by them and abide by the decision of the Organiser.

#### A. PROMOTION CONTEST

- 1. This Contest is open to the cardholders of Automated Teller Machine ("ATM") MyDebit Cards issued by participating MyDebit Financial Institutions in Malaysia ("the Cardholders"). Only Cardholders who are 18 years of age and above and have valid identification document (example: identity card or passport) are eligible to participate in the Contest.
- 2. Cardholders must charge retail purchase transaction via ATM MyDebit Card for a minimum transaction of Ringgit Malaysia Two Hundred (RM200) in a single receipt in any participating Isetan's outlets, during the Contest Period and complete the Contest form which is available at Isetan's information counter ("the Participants").
- 3. The Participants must also have an account with the MyDebit Participating Bank which is valid, non-dormant and in good financial standing, during the Contest Period up until redemption of the Prizes. The Participants shall comply with the eligibility requirement above in order to be an "Eligible Participant".
- 4. The Participants shall comply with the eligibility and qualifying requirement above in order to be considered as an eligible entry(ies) ("Eligible Entry(ies)")
- 5. There is no limit to the Eligible Entry(ies) entered by the Participants but entries performed outside the Contest Period will be disqualified.

## B. SELECTION OF WINNERS

- 1. The Participants will be required to complete the Contest form which is available at any participating Isetan's information counter.
- 2. There will be two (2) simple questions and a slogan to be answered and/or completed by the Participants.
- 3. There is no limit to the number of contest form can be submitted by the Participants. The Contest form that are incomplete, unclear, without attachment of original receipt of valid purchase and/or not satisfactory in any way howsoever will be disqualified at the Organiser's sole and absolute discretion.
- 4. Non-compliance to any of the Terms and Conditions of this Contest will result to disqualification and rejection from this Contest. An alternate winner from a reserved list will be awarded with the Prizes.
- 5. All contest forms must be submitted to Isetan at the designated contest box located at all participating Isetan's stores latest by 10 p.m.,on 31<sup>st</sup> December 2018. Any late submission thereafter shall not be accepted.
- 6. Isetan outlets will compile all the contest forms and segregate qualified and non-qualified contest forms based on the correct answers, qualified receipts(s) and complete form.
- 7. Selection and random draw for the Prizes will be conducted by the Organiser through random draw system after the compilation of all valid contest form(s). This process will be witnessed and verified by internal auditor from Isetan. Results of this Contest will be announced after the Contest Period and the winners will be notified via phone call, email or mail.
- 8. In the event that the Organiser is unable to contact the shortlisted winners after three (3) attempts (i.e.no reply, telephone number not in service or no connection etc), the Organiser reserves the right to select the next shortlisted winners to undergo the same process. The Organiser will not be held liable in the event the winners cannot be contacted for whatever reasons.
- 9. Each participant shall only win one (1) prize throughout the Contest Period, irrespective of the number of Eligible Entries collected by the Organiser.
