

Terms & Conditions

Get RM5 NSK cash voucher when you spend at least RM50 and pay with Alliance Bank MyDebit Card (Wave)* (Promotion).

Promotion Period & Eligibility:

1. Promotion Period: 1st October 2018 to 31st December 2018 (both dates inclusive).
2. Tempoh Promosi dan Kelayakan

1.
