- (c) And we further undertake and agree upon demand to pay any freight and/or General Average and/or charges due on the goods aforesaid (it being expressly agreed and understood that all Liens shall subsist and be unaffected by the terms hereof).
- (d) And we further undertake and agree that immediately the Bill(s) of Lading is/are received by us we will deliver the same to you duly endorsed.
- (e) Unless otherwise specified herein, the Bank's charges exclude any current taxes and future taxes that may be imposed under the relevant legislation. Upon the effective date of implementation of any such taxes in the future and wherever applicable, the Bank will be entitled to recover such taxes from us.
