Terms and Conditions

DEFINITIONS

In this Terms and Conditions, unless the context otherwise requires:

"the Bank" or "ABMB" shall mean Alliance Bank Malaysia Berhad.

"Campaign" shall mean "Family Fun Takes Flight: Kids Fly For Free Visa Credit Card Campaign".

"Product" shall mean ABMB Visa Credit Cards i.e. Visa Platinum or/ and Virtual Credit Card or/ and Visa Signature or/ and Visa Infinite.

CAMPAIGN PERIOD

- The Campaign is organised by the Bank and shall run from 19 October 2023 to 31 December 2023 (both dates inclusive) or such other time period as notified by the Bank from time to time ("Campaign Period").
- The Bank reserves the right at any time with prior notice to change the duration and/or commencement and/or expiry dates of the Campaign Period. The changes will be updated in our bank's corporate website.

ELIGIBILITY

- This Campaign is open to all individual ABMB Visa Credit Cardholders whose Credit Card is valid
 and payment is made at the point of transaction during the Campaign Period ("Eligible
 Cardholders").
- 2. For avoidance of doubt:
 - The transactions made by the Supplementary Cardholders in respect of this Campaign shall accrue to the Principal Cardholders of the same provided that the respective account of the Principal Cardholders are active, valid and in good credit standing;
 - ii. Termination of the Supplementary Card account by the Supplementary Cardholders shall not disqualify its Principal Cardholder from this Campaign.
- 3. The following individuals shall NOT be eligible to participate in this Campaign:
 - i. Non Alliance Bank Visa Credit Cardholder
 - ii. Cardholders of any Business Credit Cards;
 - iii. Cardholder(s) whose account(s) with ABMB are dormant, inactive, closed, terminated and/or unsatisfactorily conducted;
 - iv. Cardholder(s) who are deceased, or persons who have legal proceedings of any nature instituted against them;
 - v. Persons who are of unsound mind, minors or bankrupts;
 - vi. Any other persons as may be determined by ABMB to exclude according to internal policy(ies).
 - vii. Any other person(s) as ABMB may decide to exclude as per the Bank's internal procedure.
- 4. Permanent and/or contract employees of ABMB (including its subsidiaries and related companies), including their respective immediate family members are eligible to participate in the Campaign.
- To participate in this Campaign, the Eligible Cardholders are required to make a minimum booking spend of at least RM5,000 at Pick a Trip on flight bookings to selected international destinations only during the campaign period with their ABMB Visa Credit Cards.
- 6. The Eligible Spend are excluding the below:
- Cash advance fees or cash withdrawals, Balance Transfer Program, Quick Cash, Cash Instalment Plan, bill payments through internet banking, JomPay transactions, FPX transactions; quasi-cash transactions, annual fees, late payment fees, interest, finance charges; and/or any special partnership program;
- ii. Refunded, disputed, unauthorised and/or fraudulent retail transactions.

CAMPAIGN MECHANICS AND REDEMPTION

- This Campaign is not applicable in conjunction with any other on-going promotions or campaigns of the Bank unless otherwise stated.
- 2. The Campaign Reward for this Campaign shall be as per the Bank's internal policies and any decision made by the Bank in respect thereof shall be deemed final.

- 6. Eligible Cardholders who are new users of Pick A Trip mobile app will be entitled to a RM50 OFF on the first travel booking made via the mobile app using their Alliance Bank Visa Credit Card. This RM50 OFF on the first travel booking promotion is valid from 1 November 2023 until 31 December 2023.
- 7. Eligible Cardholders are required to key in the promo code "ALBKIDFLY" at the checkout page to enjoy the kid's free ticket of up to RM1, 200. Kid's free ticket is applicable on the base fare only, excluding fuel surcharges and taxes.
- 8. The Campaign is applicable on selected international destinations as listed below, and is valid on return journeys only. Redemptions are not valid for one-way journeys.

- 10. Eligible Cardholders may redeem the kid's free ticket, capped at RM1, 200 multiple times throughout the Campaign Period with their Alliance Bank Visa Credit Card.
- 11. The Campaign Reward is non-transferable to any 3rd party and is non-exchangeable for up-front cash or in-kind nor is it refundable for cash.

Promo Code Keyed in: ALLKIDSFLEW

Not eligible for redemption as cardholder does not key in the correct promo code as stipulated in clause 7 in the CAMPAIGN MECHANICS AND REDEMPTION section

Scenario 7

Return Fare Breakdown for a trip of 4pax (2 Adults + 2 Kids aged 3 and 5) to Japan via Narita International Airport on 1st December 2023 – 8th December 2023. Payment made on ABMB Visa Infinite.

Adult tickets of 2 pax = RM6,000 Kids ticket of 2 pax = RM3,600 (base fare RM2,600 + fuel surcharges, tax and other fees RM1000)

Total Fare = RM9,600

Eligible for redemption but only for 1 kid, capped at RM1,200.

As the kid's free ticket is the cap of RM1,200 and only for 1 kid, the cardholder will need to pay for 2nd kid and fuel surcharges, tax and other fees for both children.

Hence cardholder pays a total of only RM2,400 for 2 kid's flight ticket.

Scenario 8

Return Fare Breakdown for a trip of 3pax (2 Adults + 1 Kid aged 8) to Japan via Narita International Airport on 1st December 2023 – 8th December 2023. Payment made on ABMB **MasterCard**.

Adult tickets of 2 pax = RM6,000 Kids ticket of 1 pax = RM1,800 (base fare RM1,300 + fuel surcharges, tax and other fees RM500)

Total Fare before deduction = RM7,800 Total Pay Payable after deduction = RM6,600 Not eligible for redemption as cardholder does not use his/her Alliance Bank **Visa** Credit Card to make the flight ticket bookings.

GENERAL TERMS AND CONDITIONS

ABMB reserves the right to withdraw/ cancel, terminate, suspend or extend this Campaign and to add, delete, suspend and/ or vary this Campaign Terms and Conditions, wholly or in part at its discretion with prior notice by way of posting on ABMB's website, display at branch premises or advertisements or by any other means of notification which ABMB may select and such shall be binding on the Eligible Cardholders as from the date of the notification or from such other date as may be specified by ABMB in the notification. Eligible Cardholders hereby agree to access ABMB's website at regular intervals to view this Campaign Terms and Conditions.
- ABMB reserves the right to change or substitute at any times, at its own discretion as per the bank's
 internal policies, the Campaign Reward with other item(s) or reward(s) of similar value with prior
 notice via the bank's website.
- The Campaign Terms and Conditions shall be supplemental to the existing terms and conditions governing the Cardholder's Product and banking accounts maintained with the Bank ("the Existing Terms").
- 5. ABMB shall not be responsible nor shall accept any liabilities of whatsoever nature howsoever arising or suffered by Eligible Cardholders resulting directly or indirectly from this Campaign due to cardholders own action. ABMB shall not be liable or held responsible to the Eligible Cardholders in any manner whatsoever if ABMB is unable to perform any of its obligations under this Campaign directly or indirectly due to any force majeure event which include but not limited to any act of God, war, strike, riot, industrial dispute, lockout, fire, drought, flood, storm or any event beyond the reasonable control of ABMB.
- 6. ABMB shall not be responsible for any technical failures of any kind, whatsoever intervention, interruption, electronic error and/ or any failure or delay in the transmission of evidence of transactions by Visa International, merchant establishments, postal or telecommunication authorities or any other party which may affect the Eligible Cardholder's entitlement during the Campaign Period.
- 7. The Eligible Cards and accounts of the Eligible Cardholders' must at all times (i) be valid, in good credit standing and not be in breach of any terms of this Campaign Terms and Conditions or the Existing Terms; and (ii)not be terminated or closed or be made subject to any attachment, adverse orders made by Court or any authorities sanctioned by laws, delinquent and/ or invalid or cancelled as may be determined by ABMB in order to be entitled for the Campaign Reward.
- 8. ABMB reserves the right to disqualify the participation of any Eligible Cardholders or forfeit the Campaign Reward in circumstances where there is a fraudulent, unauthorised or reversal of transaction(s) or breach or potential breach of these Campaign Terms and Conditions as per ABMB internal policies. All records of ABMB on the transaction(s) made shall be conclusive and final.

For the avoidance of doubt, any cancellation, termination, suspension or extension of this Campaign or disqualification of the Eligible Cardholders or forfeiture of the Campaign Reward shall not entitle the Eligible Cardholders to any claim or compensation against ABMB or for any and all losses or damages suffered by the Eligible Cardholders as a direct or indirect result of the act of cancellation, termination, suspension, extension, disqualification or forfeiture due to the Eligible Cardholders own act.
- 10. Eligible Cardholders shall be personally responsible for all taxes, rates, government fees or any other charges that may be levied against them under applicable laws, if any, in relation of this Campaign.
- 11. Eligible Cardholders hereby give their unequivocal and irrevocable consent and authorise ABMB to use, publish and/ or display the names, any photographs taken, any videos recorded and/ or other
