Fund Objective

The Fund aims to achieve capital appreciation through investments in one (1) collective investment scheme, which invests in mobile internet and connectivity related securities. The Fund is a feeder fund and it invests in a single CIS, i.e. Neuberger Berman 5G Connectivity Fund (Target Fund). The Fund may also invest in liquid assets for liquidity purpose. In order to achieve its investment objective, the Fund will invest at least 95% of its NAV in the Target Fund and may also invest up to 5% of its NAV in liquid assets for liquidity purpose.

Fund Manager's Report

The Fund increased by 4.11% during the month, outperformed the benchmark by 1.13%.

Global equities were volatile in January, with notable strength in semiconductor names and more mixed performance across the software sector. In the U.S., December CPI data came in broadly as expected—headline inflation was in line with forecasts, while core CPI eased to a four-year low. This continued to support the view that underlying price pressures are moderating. On the geopolitical front, tariff concerns briefly resurfaced after the U.S. administration issued tariff threats against several EU countries amid the Greenland dispute. However, these risks have since eased following an agreed framework between the U.S. and NATO regarding Greenland, along with Washington pausing the planned tariffs pending further negotiations.

In the face of continued macro uncertainty, we place strong emphasis on quality but are ready to capture tactical opportunities. We keep our focus on areas with strong earnings tailwinds and visibility while maintaining our valuation discipline. We stress the importance of being nimble and plan to take advantage of market dislocations to trade up for higher-quality exposures where we see an incremental positive outlook, better earnings power, and validation of our investment theses.
