Fund Objective

The Fund aims to achieve capital appreciation through investments in one (1) collective investment scheme, which invests in mobile internet and connectivity related securities. The Fund is a feeder fund and it invests in a single CIS, i.e. Neuberger Berman 5G Connectivity Fund (Target Fund). The Fund may also invest in liquid assets for liquidity purpose. In order to achieve its investment objective, the Fund will invest at least 95% of its NAV in the Target Fund and may also invest up to 5% of its NAV in liquid assets for liquidity purpose.

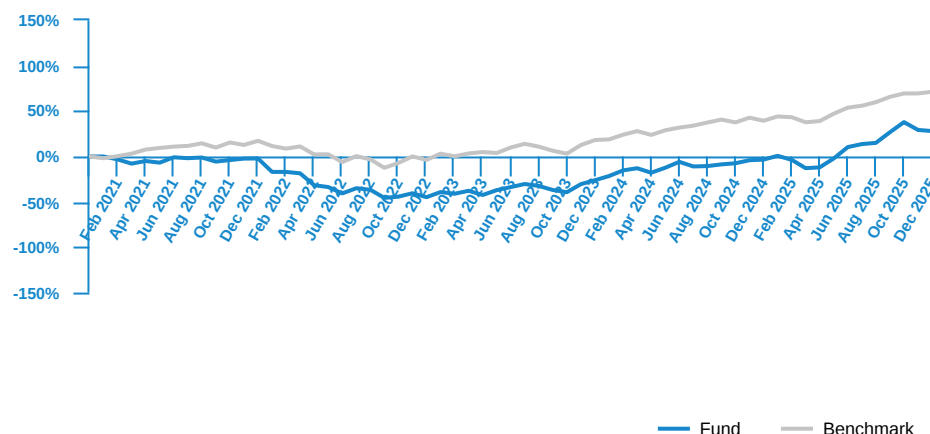

Fund Manager's Report

The Fund fell by 0.95% during the month, underperformed the benchmark by 2.02%.

Global equities staged a modest rebound in December following a volatile and choppy November, as investors digested a mix of resilient economic data, easing inflation trends, and evolving central bank guidance. The Federal Reserve delivered a third consecutive 25 basis point rate cut, bringing policy settings further into restrictive-but-easing territory. Notably, the Fed struck a more cautious forward stance, projecting only one additional rate cut in 2026. Meanwhile, geopolitical and technology trade developments drew investor attention, as President Trump approved the sale of chips to China under strict conditions, underscoring both the strategic importance of advanced semiconductors and the increasingly nuanced approach to technology restrictions.

In the face of continued macro uncertainty, we place strong emphasis on quality but are ready to capture tactical opportunities. We keep our focus on areas with strong earnings tailwinds and visibility while maintaining our valuation discipline. We stress the importance of being nimble and plan to take advantage of market dislocations to trade up for higher-quality exposures where we see an incremental positive outlook, better earnings power, and validation of our investment theses.
