Fund Objective

The Fund aims to achieve capital appreciation through investments in one (1) collective investment scheme, which invests in mobile internet and connectivity related securities. The Fund is a feeder fund and it invests in a single CIS, i.e. Neuberger Berman 5G Connectivity Fund (Target Fund). The Fund may also invest in liquid assets for liquidity purpose. In order to achieve its investment objective, the Fund will invest at least 95% of its NAV in the Target Fund and may also invest up to 5% of its NAV in liquid assets for liquidity purpose.

Fund Manager's Report

The Fund increased by 5.00% during the month, outperformed the benchmark by 5.77%.

June was marked by significant macro volatility, driven primarily by heightened US–Iran tensions that caused sharp swings in oil prices and interest rates. While an interim agreement to reopen the Strait of Hormuz helped stabilize sentiment, key geopolitical risks remain unresolved. On the monetary policy side, US inflation surprised to the upside, and the new Fed Chair signaled a more hawkish stance, keeping rates unchanged for now but increasing the likelihood of a hike later this year. Within tech, there was a notable rotation from semiconductors into software late in the month, though AI infrastructure and semiconductor exposure remained key performance drivers for the portfolio. IT and network-related themes continued to show strong secular momentum, supported by ongoing demand for next-generation connectivity, data center expansion, and AI-driven network upgrades.

We remain constructive but disciplined amid ongoing macro uncertainty and volatility. The strategy prioritizes quality, strong earnings visibility, and structural growth themes especially next generation connectivity, AI adoption, and the semiconductor ecosystem. At the same time, we stay nimble and ready to capitalize on market dislocations to upgrade into higher-quality names with improving fundamentals and stronger earnings power.
